



## And what a year it is going to be for the Pi!

EFORE I prognosticate about the coming year, I would like to say a few things about the recent past. In general, the Pi had a good '06! We kept Pi services going and on track while adding a new wrinkle or two. Membership's ever declining trend did not deviate drastically (how is this good?), and we wrapped up the calendar year with the Pi finances and forecast "in the black." There were some unplanned equipment expenses, but these were partially offset by some very generous donations. Overall, not too bad!

And as for what's coming, there are going to be a couple of new programs you should watch for. The first is Pi Dollars and it is off to a good start. There is also a series of Pi Surveys coming with one completed and a current one regarding general meetings underway. The next new program is a first. It is a Pi Photo Contest and it is in the final planning stages. Last, the impending spring elections will garner considerable attention. And this is the plan for just the first six months; who is to say what else might happen when a new Board of Directors takes over in June. Hold on to your hats!

#### 2006-What Was

A small group of core volunteers worked at keeping the Pi operating on a daily, weekly, monthly basis. Since taking over as President, the ordinary continued: membership forms and payments were processed; file servers kept Web pages and other electronic functions going 24/7; two prominent SIGs continued meeting as scheduled with well-received presentations; general meetings, with a variety of respectable topics, drew moderate crowds— a steady record.

Another steady feature of our organization is its predictable decline of, on the average, fourteen members a month. Although this isn't good, it is a manageable loss that allows us some time to address the consequences. More on this topic will be covered in communications with you in the first half of 2007.

There were some bigger measures of success, too. The Pi Picnic was held at a private residence and the event was well attended. A new *Journal* team was formed, and their first edition of our flagship periodical was published and distributed without a hiccup. A new program of rewarding participation, Pi Dollars, was initiated, and the first fruits of that labor were


well received. And last, a Pi Survey was launched to gather more information on the makeup of the membership, and the first round of the Pi Survey had a great turnout with over eighteen percent participation. Yes, the Pi was busy in the second half of 2006.

#### 2007-What Will Be (fingers crossed)

We can all expect the Pi to keep up the usual fare, and I don't see any reason that things won't keep chugging along. As a matter of fact, the budget for the remainder of the fiscal year that ends on May 31, 2007, projects a small surplus in the low thousands of dollars. A formal financial report will be forthcoming, and we will see if it substantiates that which was originally forecast. But the Pi doesn't operate on money alone.

Another source of capital is our volunteers. We currently have a dutiful group of workers who provide the necessary efforts to keep the doors open and the wheels turning. This coming year, by my estimates, there will be a modest increase in need for more volunteer help. Recruiting volunteers is one of our weak areas, and we will need to address how we cultivate and put to good use those members who want to offer

the Pi some of their time and talent. It will have to start with an energetic VP for Volunteer Services who wants to lead. The challenge is there, will someone be found?



Two new programs, Pi Survey and Pi Dollars, introduced in late 2006, will mature. One of the goals of these programs is to stimulate member involvement in the Pi. We need concerned and involved members to help spread the word about our computer user group. These programs might help in that regard.

And finally, we will kick off what we hope will be an annual event, the Pi Photo Contest! Dig out those dusty old shoeboxes of photos and find that one fantastic shot you took. Clean up your old Brownie, Minolta or Leica and start shooting some Tri-X Pan film (remember that stuff?). Open up that copy of Photoshop, which has been languishing in your Applications folder, and start learning how to enhance your images. Search through your photo portfolios for the

best shots that will fit into the contest categories. Yes, folks, this is going to be the real deal! The prizes won't be lavish but the prestige will be tremendous. Be the first to have your nameplate put on the Pi Photo Contest Traveling Trophy. Stay tuned for the full details on the Pi Web site and in other communications.

#### 2010 — What Needs to Be

Finally, there is the issue of elections in the spring. To recap, our Board consists of fifteen Directors who serve for three years. Five of the positions come open every year and are filled through election or appointment. Board members who have served for three years must sit out one year before they can rejoin the board. The problem stems from the fact that, of the fifteen Director positions, rarely have all been filled. When the current Board positions become open, there will be seven vacant positions, the five newly available and two unfilled positions from the 2005 and 2006 elections. It is going to be a challenge to encourage that many folks to come forward to fill all the open positions.

So, if you have been contemplating helping out by being on the Board, here is one way you can do so without having to commit to a three-year tour. Contact me and let me know if you are interested. We will discuss the degree of commitment and time required to effectively participate. The first one who volunteers will be appointed to the vacant position that expires in 2008, subject to Board approval. The second person to come forward will, with Board approval, be appointed to the position that expires in 2009.

As for who is going to lead the Pi starting in June, as you can figure, the current Board is squeezed real tight. Some of us "retiring" Directors will make sure the transition goes smoothly; but, in essence, new leadership will need to take over. The Pi really needs you if you have the time and desire to help. Consider it, please.  $\pi$

## Revisited— The Best of the TCS

From ways to clean LCD screens, to sharing photos over the Internet, to ripping mp4 files to a DVD, to a caution about staying out of the iPhoto Library, these TCS discussions were short on words but long on advice. Read on!

#### Introduction

HE WASHINGTON Apple Pi (WAP) has a proprietary discussion forum and it is called the TCS, which is short for TeleCommunications System. This system is accessible after log-in to any member who has an active membership account and a password, which is mailed to new and renewing members after their application has been processed. There is a detailed "how to use" guide available for download on the Pi's web site home page. Just look for the title "TCS User Guide" under the Washington Apple Pi Events heading. It is a PDF download of 2.1 megabytes.

The TCS is the "crown jewel" of the Pi—at least, that is the opinion of one member who logs onto the TCS frequently. So why the grand praise? What makes this glorified bulletin board different than other discussion forums? The answer is answers!



To be a bit more precise, most questions posed on the TCS result in quick and concise replies that give members in peril plenty of options to help them fix what is harassing their Apple computer. The answers and advice come from fellow members who generally have years of experience and plenty of credentials to back up their recommendations. And another reassuring fact, these are fellow members that you have met at the general meetings or otherwise and you can put a little more trust in someone you know versus a screen name from someone who lives who knows where.

But enough advertising—what are some of the recent questions?

#### **Cleaning LCD Displays**

12:45AM, Monday, Karen A. asks: Can anyone recommend a cleaning product for the Cinema display? (Computing Conference, Repair & Maintenance thread—text search "cleaning monitor")

2:03PM, Monday, Edward M. replies: When all else fails, "How To Clean an LCD Panel"; from below, water first.

This article describes the best way to clean an LCD panel such as those used on PowerBook computers and Apple flat panel displays.

To clean the LCD:

1. Turn off the computer or dis-

- play. You may need to turn off the computer in order to turn off some Apple displays.
- 2. Dampen a clean, soft, lint-free cloth or paper with water only.
- 3. Wipe the screen. Do not spray liquid directly on the screen.

You may also use a mild glass cleaner that contains no alcohol or ammonia. Most office supply stores sell cleaning kits specifically designed for this purpose.

While there are many commercial products available that will work without damaging the plastics, Apple has tested a product called Klear Screen made by Meridrew Enterprises (http://www.klearscreen.com) and found it does not cause any harm to the plastics. This product may not be available worldwide.

2:17PM, Monday Jon T weighs in: FWIW (For What Its Worth), the Meridrew Klear Screen (a.k.a. iKlear) has seemed to enjoy exclusive, seemingly unanimous official recommendations from the likes of Apple and Dell going back at least to the days of the Newton touch screens.

6:20PM, Monday Karen A. replies back: Thanks to all for cleaning recommendations. That's the information I needed! Much appreciated.

#### Sharing Photos over the Internet

11:20AM, Wednesday, Jonathan R. states: I want to share photos with relatives by posting the photos (which were taken at a wedding) on the Web. I want my relatives to be able to save the photos onto their computers. Can anyone recommend any sites for doing this?

12:18PM, Wednesday, Lawrence C. replies: Picasa. There is a free tool to help you upload; it requires Mac OS X 10.4, and the Web site is free, too (requires a Google account, also free): http://picasa.google.com/web/mac\_tools.html

1:14PM, Wednesday, David O also replies: I use Flickr to post photos for our autocross club. It works great for that. I upload using an export tool within iPhoto. I upload the photos in full resolution. Anyone downloading them can choose the size they wish to download. If you want to take a look, my site is <a href="http://www.flickr.com/photos/ogburn">http://www.flickr.com/photos/ogburn</a>. There is a free version and a pro version that is about \$25 per year.

1:48PM, Wednesday, Blake L. answers: I think the Washington Apple Pi members area is a good choice for posting photos if you are an Explorer member. It is less likely to be blocked for people accessing the Web from work. I routinely get blocked from access to popular photo, video, and podcast sites.

10:59PM, Wednesday, Hal C. offers: If you have a .Mac account, you can put them in your Public folder and password protect it, or not, depending on your preference. Then they just go to that link, sign in, and drag the photo(s) to their desktop.

#### Converting mp4 Files to DVD

4:19PM, Monday, Paul S. asks: Does anyone have experience ripping DVDs and converting the files to mp4? (Computing Conference, Digital Video thread - text search "Converting DVD Files")

5:20PM, Monday, Hal C. offers: Handbrake works, converts to several formats, including mp4.

The time I used it was to extract a sequence that was originally shot on 8mm film stock, then converted by an old college buddy by shooting the projected image and saving it to VHS.

So the quality wasn't that great. That, I think, was because the original DVD wasn't very good.

It did take a long, long time, so 'Patience is virtue'

5:27PM, Monday Jon T weighs in: Handbrake is the current darling, by a wide margin. http://handbrake.m0k. org/ There are of course others, but this may be all you need for a while.

9:29AM, Tuesday, Paul S. responds: There is a clear consensus to use HandBrake, available as freeware. I have now tried it and find it perfect for my purpose.

#### Valuable Hint regarding the iPhoto Library

5:01PM, Tuesday, Pat F. states: I am working on the next Pi Fillings CD and I ran across this in a Small Dogs Electronics newsletter.

iPhoto File Structure by *Ed@ Smalldog.com* 

I could condense all my iPhoto wisdom in one sentence: for your own benefit, please never, ever open the iPhoto folder library folder and move files around. That's it. This is because iPhoto has to maintain a very strict inventory of its data. The data structure is explained here: http://www.iphotolibrarymanager.com/Documentation/iPLM/pgs/libraryfolder.html

There really is no reason for the vast majority of users to ever open their iPhoto library folder. That includes me!

## Did You Know?

All web browsers are not created equal!

ID YOU EVER wonder why some Web sites won't display right and some just don't load at all? Something is wrong with the Web site, right? Well, not so fast. Maybe it is your Web browser or, more specifically, the browser's settings. Do you allow cookies? Are Java and JavaScript turned on? Have you selected to load images?

Here are a couple of pointers that might help when you encounter Web page display problems.

Try another browser. But don't try Internet Explorer. Microsoft has not supported Internet Explorer on the Mac for several years, and subsequently it lacks the same functionality as more modern browsers, and has many security weaknesses too. Apple's Safari is the standard browser that comes with Mac OS X, but there are three excellent, well-supported third-party browsers (see references at end of article) available at no cost. Firefox, Camino or Opera just might open those Web pages that Safari can't seem to deal with. Give them a try.

Optimize your Web browser's Preferences. Go to the left side of the top menu, and, as with every application, under the application title you will find its associated Preferences. There are numerous settings that you should review and adjust based on your model of Mac and speed of Internet service.

Four important ones are for Cookies,
Java, JavaScript and image loading.

Choosing to not accept cookies could inhibit a Web page from loading. Some folks don't trust cookies -- these bits of data that a Web site places on your machine to better facilitate follow-on connections. However, such sites may not load at all because they are looking for the cookie information to complete the process.

Similarly, many Web sites use Java and Javascript (two different programming languages) to enhance Web page presentation and capabilities. If these options are not selected, you may run into problems when using an older operating system. Finally, if you have selected to load images, depending on your machine and Internet connection

speed, a site with a lot of graphics and animation may appear to stall as the numerous large files are being loaded onto your computer.

A side note. Have you ever wondered why the opening page of the Washington Apple Pi Web site has limited graphics and images? The principal reason is to facilitate quick loading of our Web pages. Many of our members are using older, slower equipment coupled with dial-up Internet service. Either of these will result in slow page loading when complex structures and lots of graphics are involved.

With quick-loading, content-rich pages, Pi members and other visitors should see a page in seconds, and seconds count. A November 2006 study released by Akamai Technologies states, "Four seconds is the maximum length of time an average online shopper will

wait for a Web page to load before potentially abandoning a retail site." While the Pi site is not a retail site, the Akamai study confirms that Internet users are finicky, and impatient.

So now, armed with a little more knowledge about your web browser choices and preference options, you can adjust your settings to cope with web pages that are giving you problems. Happy web surfing!  $\pi$

## Encrypting Mac Laptops to Comply With Government Directives



N RESPONSE to the (temporary) loss of 26.5 million names and associated personally identifiable information (PII) last year, on June 23, 2006, the Executive Office of the President, Office of Management and Budget ("OMB"), issued a memorandum, M-06-16. This recommended that all executive departments and agencies encrypt all data on mobile computers and other devices unless the data was determined to be

non-sensitive. Unfortunately, the OMB *suggestion* also suggests that the Deputy Secretary (in other words, a subcabinet political appointee) personally declare that a given device does not carry PII.

The idea of a senior political appointee personally sorting through the tens of thousands of laptops, key chain drives, external hard drives, USB mice with flash storage, and other mobile data devices, looking for PII, has a certain appeal—matching form and function to talent and ability. Sadly, that's not going to happen; political appointees are too busy looking for more prestigious jobs.

Instead, in addition to introducing the silly looking abbreviation PII into the technical vocabulary of secu-

rity professionals, the edict essentially requires that *all* government laptops be encrypted, as it is easier to issue blanket requirements than it is to exercise proper personnel oversight and leadership. Many cabinet agencies extended this requirement to contractor machines as well. The memorandum triggered a massive purchasing spree at the end of the federal fiscal year 2006 and the start of the fiscal year 2007, as thousands of agencies and contractors attempted to encrypt hundreds of thousands of laptops, in the process probably destroying more data than they protected.

#### Windows Security for Macs?

Of course, most of this effort was focused on the Windows world, since

the infamous lost laptop was running Windows and, in fact, most government laptops run Windows. Virtually all of the solutions purchased work with Windows only. So what is a Mac user supposed to do?

From the beginning, Macs really were not an issue. Mac OS X is far harder to break into than Windows, and Macs tend to be used more for creative functions (web design, Java programming, photography) and scientific purposes (gene processing, hazmat identification, astronomy) than personnel matters.

And, of course, there is FileVault.

FileVault is one of those technologies that Apple built in to Mac OS X, but doesn't really talk about. It isn't as sexy as *iPhoto* or *iTunes*, or as useful as *Safari* or *Mail*. FileVault, from a user's point of view, does absolutely nothing, so it gets ignored. Yet FileVault, included with every copy of Mac OS X 10.3 and 10.4, is just the ticket for complying with the OMB M-06-16 memorandum. You don't need to go out and buy anything extra; it is right there, waiting to be used. So how do you use it?

#### **Recommended FileVault Preparation**

**Start with Mac OS X 10.4.** While FileVault is included in Mac OS X 10.3, it is recommended that you upgrade to

Mac OS X 10.4 before encrypting anything. There is extensive anecdotal evidence that FileVault is more stable and dependable under Mac OS X 10.4, so use that as your starting point. You should also ensure that Mac OS X 10.4 is fully updated; keep on making trips to System Preferences > Software Updates and installing updates until nothing more is offered.

Start with a healthy

disk drive. You also need to ensure that your hard drive is in good working order. Launch *Disk Utility* (in the Utilities folder) and use the Disk First Aid tab to Verify the hard drive. If any problems are found, correct them; don't even think about trying to encrypt a hard drive that has errors.

- Visit http://www.titanium.free.fr/ and download Maintenance (it is free).
- Install Maintenance on the Desktop and launch it. You will be asked for an administrative password.
- There are three panels in the Maintenance menu. Uncheck everything in the top panel and the bottom panel, but leave everything in the middle panel checked. Then select Execute.
- It can take quite a while for Maintenance to clean out cached files, so be patient. When it is done, you must reboot.

Start with adequate room on the drive. From the Finder, select your user directory (it looks like a house, and is named with your log-in name). From the Finder menu, select Get Info. A window will appear that shows, among other things, the size of the directory. Depending on the amount of information the user has on the computer, this could take several minutes; the phrase "calculating size" will appear while

Make sure you read and understand everything in the warning prompt before turning on FileVault. Otherwise, this will be the last time you ever see anything on your computer.

the computer is conducting inventory. Then, from any Finder window, note the available space left on the drive. If you don't have more free space than your user directory requires, you won't be able to encrypt your disk; you will need to archive data to free up space.

Remove miscellaneous files. File-Vault encrypts everything, even garbage, so it is a good idea to get rid of various cache files first.

#### **Enabling FileVault**

Make sure the computer is plugged into power and can be left alone for an extended period of time. Encryption can take minutes or hours, depending on a number of factors.

**Log into the computer**, select System Preferences, and select Security.

Set the Master Password. The Master Password should be a lengthy (at least 12 characters) password that you never use for any other purpose. Once you've entered it, write it down on a piece of paper, seal it in an envelope, and put it in a safe or other secure area. The Master Password is used for recovery of your encrypted information in case you ever manage to forget your log-in password.

Turn on FileVault. You will be prompted for your normal user password (not the Master Password).

FileVault will display a warning that it is about to be turned on. Note the

checkbox for Secure Erase. Check this box if the computer has sensitive data that must be erased; otherwise leave it unchecked. By checking this box, the encryption process will be extended by least **eight times** the normal span of time.

If you did not properly calculate the amount of space required, FileVault will stop and ask you to free up space.

Once encryption is started, a progress bar is displayed along with an estimate of the time the process might take.

If you accidentally touch a key, you might stop the process, which will delay the job. Make sure the machine can be left alone, plugged into power, for several hours (in some cases).

Once the encryption process is finished, the machine will be left at a login screen. Have the user log into the machine and confirm it is encrypted. The login process will take a few extra seconds (as will logout) once the machine is encrypted.

#### Routine Use with FileVault

Aside from taking slightly longer to log in and out, using a Mac with FileVault is transparent; a user is unlikely to notice a difference. One exception to this rule: video editing. If you use a laptop for video capture, you may have trouble saving a video stream to an encrypted disk drive.

If the user deletes a large volume of information, they may see an offer that FileVault can reclaim the extra space. Be sure and answer this question, and do *not* interfere with the process; killing power instead of answering the question can be bad. Very bad.

## Computing on the Horizontal: Life with a MacBook Pro



T HAD BEEN four years since I had last upgraded my computer, though I had generally made some effort to keep up with the technology. This replacement had two inspirations: first, Apple had come out with the new, Intel-based line of Macintoshes. Second, last year I developed a blood clot in my left leg, and the leg has not quite recovered, still getting swollen and uncomfortable if I sit for an extended period of time.

So I quickly decided I wanted a laptop with a wireless interface that I could use while in bed with my leg propped up. Once convinced, after discussions with an Apple Store employee, and after reviewing the various descriptions online, I knew what I wanted. I was going to go high-end, acquiring the MacBook Pro with a 17-inch display, as much extra memory as could be stuffed in it, and an AirPort base station.

I did buy AppleCare for the laptop, something I had previously shunned and never regretted for my desktop machines, but laptops are more finicky. Also, with a \$100 rebate offer, I bought a Hewlett-Packard PSC-1610 combination printer, scanner and copier. The net cost was about \$30, and it allowed me to replace my old Canon scanner and printer with something more upto-date that took up half the space.

At home I immediately began configuring things. Apple, as usual, walks you through the various steps with a great deal of handholding. Everything went quickly and smoothly until it came time

to copy files from my old iMac over to the laptop. This was still smooth but was clearly going to take several hours, so it was time to go to bed.

I awoke in the middle of the night and went in to check on the laptop. All the files had copied over. This was something of a mixed blessing. It was definitely less painful than the transition from my PowerMac to the iMac, but at the same time it avoided any opportunity to clean up and organize.

The next evening it was time to set up the network. That again proved, with Apple handholding, to be fairly quick and smooth. I plugged in the Air-Port Base Station, hooked it to the cable modem, and then ran through the steps in AirPort Setup Assistant as directed.

My next goal was to get the two computers communicating with each other. This proved to be a lot more difficult than I expected. Once I had enabled personal file sharing on both machines via AirPort, I found that the iMac could see the laptop but not vice-versa.

To make a long story short, after some online hair-tearing on the Pi's TCS discussion boards as well as some actual research, I learned that Apple π

had changed their networking protocols with Tiger. I decided to upgrade the iMac to Tiger and that fixed the problem.

#### **Getting comfy**

This next issue was not directly a technical one, but more a matter of finding a way to use the laptop comfortably whilst lying in bed with one leg propped up. Putting the laptop directly on one's lap is not recommended, nor is putting the laptop on a pillow (the bottom of the Mac-Book gets very hot).

I eventually settled on a product from The Comfort Store called the Laptop Laidback (http://www.sitincomfort.com/laplaidtab.html), which is an adjustable, lightweight, portable wooden table that straddles my waist while I'm lying in bed and provides reasonable support and placement for the MacBook. The only disadvantage is that it's hard to move much with the table seemingly imprisoning me, and I have a hard time if I need to get to the phone in a hurry.

#### More power, Scotty!

Battery usage is always a key issue for laptops. I was initially appalled when I watched the battery charge percentage drop almost visibly the first couple of times I was unplugged, at a rate that would have had me dead in the water in under forty-five minutes. However, I soon remembered that I was running Seti@home, a background program that does massive amounts of numbercrunching with the spare CPU cycles on one's computer in a highly quixotic attempt to detect signals from alien civilizations. Disabling SETI ended the precipitous drain on the battery. I haven't really tried to see how long the laptop will hold up, though I did once watch a ninety-minute downloaded video and still had about 30 percent to go at the end.


The power cord itself is a nifty Apple

innovation, at least the end that hooks to the computer. It's magnetically rather than mechanically attached to the side of the laptop, so that if you absentmindedly pull the laptop away from the power, it simply disconnects rather than either ripping the power cord or yanking the computer out of your hands. However, the slightest stress is enough to pull it free, which can be annoying at times.

#### **Email conversion**

For many years my email program has been Eudora, plain but effective. However, its interface has not kept up with the times on either the Mac or Internet fronts: the look-and-feel harks back to the days of 25x80 text-based displays, and it doesn't handle HTML-formatted emails very well.

So, I decided to switch over to Apple Mail. This proved to be straightforward — except for converting over my old emails stored in Eudora's format. I don't recall exactly how they came through, but it was ugly. I was about ready to give up and go back to Eudora

when I did a Google search on "Eudora Apple Mail conversion" or something similar and came up with a free utility called Eudora Mailbox Cleaner (http://homepage.mac.com/aamann/Eudo-ra\_Mailbox\_Cleaner.html). Deleting everything I'd done so far and running EMC gave me a clean setup under Apple Mail with all my many emails over the past however many years still intact.

#### **Backups**

My initial thought had been to use each computer as the backup for the other, but that's rather problematic when the MacBook has 120 gigabytes of disk space, and the iMac only has 40. Instead, I ended up buying refurbished LaCie Firewire 120 GB drives, one for each computer, as a backup destination.

The software package I use for much of the backup work is called Chrono-Sync (http://www.econtechnologies.com/site/Pages/ChronoSync/chrono\_overview.html). ChronoSync provides the capability to mirror a folder or group of folders, which has come in very handy.


#### Fixing up the iMac

I had one issue on the iMac: I had partitioned an external drive I was using before for several purposes, including holding my wife's iTunes music collec-




Now spam comes in decorator colors! (Note also numbered mail folders on left, since otherwise Mail puts them in alphabetical order regardless of where you want them.)

tion. Unfortunately, the partition was just a little smaller than what her iPod could hold, which she found somewhat annoying. With my move to the laptop, I no longer needed one of the partitions on the drive. Unfortunately, Apple provides no means of repartitioning a drive without erasing all the data on it as well. Fortunately, SubRosaSoft.com provides a solution with their \$49.95 product VolumeWorks, which deleted the old partition and allowed me to add the freed space to Tina's music partition, all without losing a byte of information.

#### Changes and improvements under Tiger

Safari: The biggest improvement in Safari for me is RSS feeds. RSS feeds are a way for a Web site to tell you that it has changed, particularly for sites containing news items or blog entries, as well as giving you some idea of what that new entry might be. I'm into keeping up with astronomy and science news and typically check on the order of 50 sites a day for this information, having taken unofficial responsibility for keeping an astronomy and space exploration forum (the Bad Astronomy and Universe Today forum at http://www. bautforum.com) up-to-date. As such, RSS feeds are a lifesaver for me: I can check for updates on 40 of those 50 sites in a matter of minutes (the latter 10 don't yet have RSS feeds).

Spotlight: Click Command-space, enter a search string, and it'll get found wherever it is on your computer. I already had LaunchBar, which does pretty much the same thing, so Spotlight doesn't seem like that much of an improvement.

Dashboard: Click on the Dashboard icon in the Dock, and you get an assortment of gadgets that pop onto your display. The weather forecast, a calculator, a clock, and a calendar are the defaults. There are also numerous available add-ons. I've installed one

that allows me to make entries into Quicken without bringing up the program.

#### **Printing and scanning**


I haven't done a lot with the Hewlett-Packard PSC-1610 combination device, but what I have done I've been happy with. It's an inkjet printer, but compared with my old Canon S300, it prints more darkly, more quickly, and more quietly.

#### **Final thoughts**

Overall, I'm pretty happy with my new setup. I can spend extended periods of time on my computer at home now for the first time in many months, and the MacBook is an order of magnitude faster than the iMac. There are various things I can do that I could never do before: a few weeks ago I provided play-by-play updates on a televised soccer match via a message board for the benefit of some folks who didn't have television access at the time the game was going on.

The downside is a certain degree of addiction: when you can check your email in the middle of the night, you can easily develop a compulsion to do so, and there always seems to be one more thing I want to do on the computer before I turn out the lights. There is also the issue that I am more accessible to our cats in this position and sometimes have to take a break because there's one sitting on my chest between my face and the display. But that's a small price to pay for comfort and convenience.  $\pi$

#### Just the Facts

CTOBER'S MEETING was modestly attended with a presentation of *VectorWorks*, a 3D CAD program, leading the event. Club business regarding upcoming meetings, the Pi Survey, and Pi Dollars was covered before the attendees split into two smaller sessions. The *VectorWorks* demonstration continued in one room with a focus on the program in greater detail, while a Question & Answer ("Q & A") session was conducted in an adjoining room. The Q & A expanded into live demonstrations as the topics evolved from the initial inquiries. Door prize drawings by random selection finished the event.

#### Details, Details, Details

VectorWorks — Our main presenter was Michael Pacylowski, president of Kickpoint Solutions, Inc., who first presented a general overview of Version 12.0 of VectorWorks. The program was touted as the best Mac CAD program available, and Michael stated that the program owns fifteen percent of the Mac CAD market. Michael proved to be a highly capable presenter as he quickly moved through various aspects and features of this impressive program. The audience was enthusiastic and several questions dotted the presentation. Michael did a great job of dealing with these as well.

Mini-training Session A—After a short break and the club business portion of the meeting, the VectorWorks demonstration shifted into high gear with a more in-depth presentation. Mini-training Session B—Pat Fauquet conducted a Q & A session with a detailed demonstration on how to create a secure disk image on your Mac. She explained the purpose for this secure storage methodology, and then, with the aid of the overhead projection screen, she went through the steps of creating a secure disk for everyone to witness. 
#### Retired SIG Meeting, October 2006: A Keynote Demonstration and More

#### Retired SIG Meeting, November 2006: Backing Up

Len Adler

N THURSDAY, November 16, despite blinding periods of heavy rain, seven hearty Pi members came to see and learn how backing up data could be done. Nancy Little demonstrated how she uses her .Mac account and Apple's Backup (a free backup utility included with .Mac membership) to save and protect the data on her Mac. Among those interested were users who had .Mac accounts and had yet to use the Apple Backup program or any other function of that service.


Len Adler, the SIG leader, also discussed a simpler way of backing up using an external hard drive. Len showed everyone how to simply drag and drop from the Mac to the external drive's icon, which appears on the desktop. The disadvantage of doing it this way, of course, is that this is a manual process and only occurs when you remember to do it.

Using Apple's Backup, and other backup programs like Super Duper, Retrospect, and Carbon Copy Cloner, allows the user to set a daily time for backup; then, if the external drive is on and connected, the program will do the backing up automatically. Other backup options include burning to a CD-ROM or DVD, and if you have a .Mac account, you can even back up to your iDisk storage space on that account. That means that, while you are away from your computer, such as when you are sound asleep in the middle of the night, your Mac can be wide awake and working away backing up the files you designated.

Paul Silverman asked about storing big photo and music files from the Mac's internal hard drive -- how can that be done and how can it save space for new stuff? Unfortunately, no one in our limited group could answer those questions. We will try to provide Paul with an answer before the next meeting.

We still have questions about the use of other tools to store data externally. Also, some of us burn data onto a CD or a DVD. It is always interesting to me to see the many ways there are to do a particular computer task. It makes the sharing worthwhile -- we learn so much about how we can approach a problem on the Mac.

Our next meeting will be Thursday, January 25, at 1:00 p.m. Watch for the topic of the meeting to be announced on the Pi Web site.  $\pi$



#### Graphic Arts SIG November 2006

HE GRAPHIC Arts Special Interest Group met Saturday, November 11, at Mac Business Solutions in Gaithersburg, Maryland.


Michael Giagola was back, continuing his series on Digital Photography. The topic for this meeting was: "Exposure and Lighting for Digital Cameras."

One of Michael's key points dealt with Auto Exposure and digital cameras. He stated that Auto Exposure can produce good results under many circumstances, but it can also be fooled. To illustrate this, Michael set up a well-lighted scene, populated with a three miniature stuffed animals—one each of white, brown, and black-against a standard 12 percent grayscale background. By changing only the exposure he demonstrated that he could change the grayscale background from white

to black, with equally dramatic effects on the subjects. Too much light, and the whites are "blown;" too little and the blacks are "lost."

#### Highlights of WAP Board Activities, October – November 2006

Pi Secretary, Gabriel Roth

The following are some of the significant activities that occurred in October and November.

Survey of Pi members. To find out more about membership computing interests and otherwise, a series of surveys are planned with the first implemented in November. As of November 26, 2006, there were 158 responses received. Over fifteen percent of the membership has participated to date. The first survey will close on December 2, 2006.

**Photo contest.** Following a proposal by Vice President for Publicity Tom Carlson, a Pi Photo Contest team has been developing plans for a photo competition (see ad on inside of front cover). It is hoped the event will be launched in early 2007 and the winners announced before the summer.

Meetings with local Mac dealers. Contacts continued with the managements of Absolute Mac, Mac Business Solutions and MacUpgrades. One of the topics being discussed is ways the Pi could help the dealers to better acquaint their customers with the capabilities of their new machines. Pat Fauquet is assisting with researching tutorial course materials for such customers, some of whom we hope join the Pi.

Cooperation with Absolute Mac. Raul de Arriz, owner of Absolute Mac, is particularly keen to work with Pi members on the music capabilities of the Mac, and he has offered to help restart the Pi's iLife and Music SIGs. [Raul formally discussed some of his ideas and with the help of Mark Gruen, demonstrated the Mac's music capabilities at the November General Meeting.]

New location for General Meetings. The arrangement to hold General Meetings at Microsoft's Innovation and Technology Center in Reston ended in 2006. Board members have been seeking other premises that are accessible, inexpensive, and allow our regular meeting activities, such as the sale of Pi Fillings CDs. Bob Jarecke and Pat Fauquet found suitable facilities at Luther Jackson Middle School at 3020 Gallows Road, Falls Church, and arranged to reserve them for the first three meetings in 2007.

**Pi Dollars.** The Board engineered and, for the November meeting, launched "Pi Dollars." Their purpose (as illustrated by their green color) is to serve as an alternative currency in case the US Treasury dollar fails. They are also for use in General Meetings to bid for door prizes. Their introduction on November 18 was a huge success thanks to the auctioning skills of Steve Roberson.

Resignation of Vice President for Volunteer Services. Steve Lipson submitted his resignation as VP for Volunteer Services, and the position is vacant at this time. His resignation was accepted with regret and hearty thanks for the work that he had done. Steve remains a member of the BoD.  $\pi$
